Sealed bids addressed to the Manager Materials, Pak-Arab Refinery Limited must be deposited in the Tender box placed for this purpose at main security gate of PARCO's Corporate Headquarters, Korangi Creek Road, Karachi up to 1030 hours on **15 September 2023**. Bids will be opened at 1100 hours the same day (through an Online Bid Opening Session) in the presence of bidders or their authorized representatives.

Bids must be accompanied by a Bid Bond in the form of Bank Draft or Pay Order (cash or cheque are not acceptable) drawn in favour of **Pak-Arab Refinery Limited** in an amount equal to **5% (Five Percent)** and a post-dated cheque (Ten days from the Bid Opening date) of **25% (Twenty-Five Percent)** of the total bid value. Bids submitted must remain valid for acceptance for a period of 90 days from the date of bid opening. Bids submitted without Bid Bond shall not be accepted. Bid Bond of successful bidders who fail to make payment of the bid amount or fail to lift the Scrap Material in time specified in Tender document shall be forfeited.
